Spotlight

In our ongoing efforts to salute merchants and residents in the community who are making significant contributions, The Trumpet salutes Mr. Edward Braddy, owner of the North Avenue Burger King. He was born in Dillon, South Carolina and



moved with his family to Baltimore in 1961. He is a graduate of Baltimore City High School and later attended Baltimore City Community College. He joined the Baltimore City Police Department and worked on the force for five years. His restaurant management career began with the Marriot Corporation's Hot Shoppe fast food restaurant. Later, he transferred to the Marriott on Baltimore National Pike and worked for a year. Mr. Braddy is a visionary who was always thinking of employing residents from the community.

His Burger King career began as an Assistant Manager in 1976. Because of his hard work, dedication and sales successes, he was promoted to General Manager in 1979. He continued to climb the ranks as he focused on employee development and retaining skilled employees. In 1981, Mr. Braddy was promoted to District Manager. Two years later he was promoted to Director of Operations and responsible for overseeing twenty stores from 1983 through 1987. With his determination to empower Baltimore City residents, Mr. Braddy purchased the Burger King in the Waverly Shopping Center in 1988. The store was successful until one of his competitors moved across the street with double drive—thru windows. Subsequently, Ed sold the business back to the franchisee. His determination for success opened

an opportunity for him to become the General Manager of two Pizza Hut restaurants.

Mr. Braddy learned where the federal government deregulated pay phones. At this point he opened his own pay phone business. He used his contacts from Burger King to place pay phones in restaurants. Mr. Braddy and his partner owned 300 pay phones. When his partner was killed on Father's Day, Mr. Braddy sold the payphone business and acquired the Burger Kings from LaVan Hawkins. Ed became an equity partner and helped to opened three previously closed Burger Kings. (Orleans Street, North Avenue and Cold Spring Lane).

In 2010, Mr. Braddy decided to go out on his own. He finalized a deal and became the CEO and owner of the North Avenue Burger King. Currently, he employs thirty-two people. "Helping people has been the best part of this experience. I see the same people and have gotten to know the residents of the community. My faith is in God because He is why I am where I am" he stated.

Most impressively, Mr. Braddy has contributed financial support to the Druid Heights Educational Enrichment Summer Fun Camp program, provided meals for the "We Can Achieve" program and continues to employ people from the community. Mr. Braddy is married to his beautiful wife Lesia and is the father to five grown children and he has five grandchildren. He is a member at New Antioch Baptist Church in Randallstown where he serves on the Trustee and Usher Boards. With his heart to serve and give back, Mr. Braddy made arrangements with the Fulton Avenue Baptist Church to collect their receipts from his store and return for a 15% cash rebate to the church. Mr. Braddy extends this offer to the Druid Heights CDC congratulates Mr. Braddy for his great works, community empowerment and economic contributions. He is a role mode and a great business man adding to the value to our community.

Community's Residential and Commercial Real Estate Development Reaches New Heights



Mr. Roscoe Johnson III is the **Director of Real Estate Development** for Druid Heights Community Development Corporation. His focus and hard work has brought newly constructed homes and beautifully renovated properties in the community. The economic impact of the Baker View project includes the return of vacant lots and inhabitable properties to Baltimore City's tax base and creation of employment opportunities for community and city residents. We are grateful for the continued support of **State Farm Insurance Companies** for their \$9.7 million dollar investment in Druid Heights.

THE COMMUNITY IS PROUD OF THE BAKER VIEW HOMEOWNERSHIP initiative because it will immensely benefit the community in many positive ways. It will not only address the slum and blight issue; it will offer superior quality homeownership opportunity for affordable living in Baltimore City. Baker's View will provide stabilization and great enhancements to the existing, well established Sanford-Cumberland corridor. The average square footage for the townhomes is 1,800. The current sales price is \$109,000. The area's redevelopment reduces the number of houses from 214 to 87, creating open green space and limited vacancies in the community.

THE GATEWAY HOUSING INITIATIVE targets existing vacant houses between the 1800 – 2200 blocks of McCulloh Street and Druid Hill Avenue. These streets serve as the entry and exit points for the community. The project will also target stable blocks where vacant buildings exist. The houses will include green technologies building materials that will improve environmental energy efficiency and conservation goals. An additional benefit with purchasing a Gateway property is the Maryland State Historical Tax Credit incentive. The sales prices for the units will range from \$143,000 \$185,000.



The economic impact of the Gateway project has created skilled and unskilled job opportunities for community residents. There will be a variety of options offered to the homeowner. We are proud to see these homes restored while maintaining the historical integrity of Druid Heights.



THE SPHINX CLUB COMPLEX project will re-develop and renovate vacant properties 2101 – 2111 Pennsylvania Avenue into a restaurant /cultural arts venue that will incorporate the restored façade of the historic Sphinx Club for the restaurant and new construction that will create enclosed outdoor seating to increase the vibrancy of street life. To date, the project has received funding from the State of Maryland Department of General Services (\$35,000) and the Department of Planning African American Heritage Preservation Program Grant (\$100,000) to cover construction costs.

THE FRANKLIN ENTREPRENEURIAL AND APPRENTICESHIP CENTER

is coming to the corner of Madison and Gold Street. Druid Heights Community Development Corporation in partnership with St. Martin's Church of Christ intends to use this existing structure to provide a haven for artists of all disciplines, training in trades, skill development and most importantly, entrepreneurial and apprenticeship opportunities. This amazing facility will light up the north east corner of the community and create jobs for people around the city.
