While the organization continues to pivot through the pandemic, the community need to continue to be great. DHCCDC continues to serve low-moderate families, build affordable housing for first-time homebuyers, provide housing to senior citizens, provide transitional housing for women and children, and provide homebuyer counseling to residents.

The mission of DHCCDC is to cause, encourage and promote community self-empowerment through the development of economic, educational, employment and affordable housing opportunities. DHCCDC works to fulfill our mission through several departments which include real estate, housing counseling, community outreach and re-entry programs. The community center currently serves as a hub within the Druid Heights community.

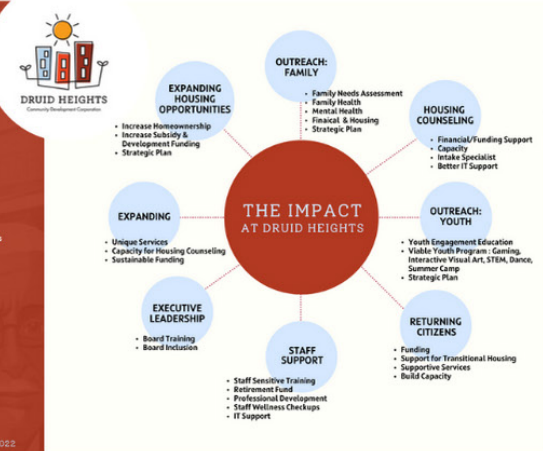
In addition, Druid Heights Community Development Corporation the Druid Heights Maggie Quille Community Center provides youth services that includes an after school academic tutoring, homework assistance, and summer camp. These services are targeted towards our low-moderate income residents and families. The Druid Heights Educational Culturally Enrichment Summer Fun Camp provides an enrichment camp during the summer months DHCCDC is a grass-root, residents driven and community focused organization. Neighborhood residents are committed to leadership, community service, advocating and supporting the planning and development of the community. Their input and volunteer support are essential to the operations of our community outreach program. As DHCCDC continues to build residential and commercial properties, our strategy is to "build people first." 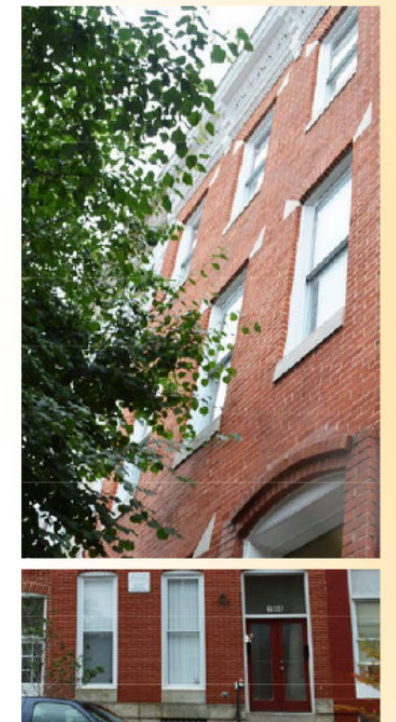

Druid House Transitional Housing

In 2000, DHCDC implemented the Druid House Transitional Housing Program which consists of 24 residential rental units. This project was financed using tax credits, grants and loans from the State of Maryland Department of Housing and Community Development, Baltimore City Department of Housing and Community Development, and Enterprise Community Partners. Druid House entails 14 units in the apartment complex located at 1711 McCulloh Street, which is a renovated apartment building with a community room and outdoor courtyard space for residents' use. Druid House also includes ten additional units which are located in duplexes along McCulloh Street. The Druid House Transitional Housing Program is one of the few programs that exist in Baltimore City that provides normal living apartments as shelter for women and children. The number of homeless women is steadily increasing with limited resources to assist this particular population. Druid House program goals and purposes is to provide homeless women and their 10 families with a safe environment and needed resources in order to promote independence and self-sufficiency.

Advancement of Bakers View Townhomes Project Aiding City in Blight-Elimination Efforts

More affordable housing is on its way to West Baltimore! Druid Heights recently celebrated the advancement of Phase II of the Bakers View Townhomes project with a groundbreaking ceremony at the corner of Baker and Division Streets. Phase II of the four-phase affordable-housing project will include up to 21 newly constructed townhomes.

In March 2020, the Druid Heights community cut the ribbon on six of the 21 homes. Eight more townhomes are slated for the 2300-block of Division Street and seven more will be constructed in the 500 block of Baker Street.

The City has eliminated more than 40 blighted properties for Phases I and II of the Bakers View project. DHCD gave \$1.1 million in bond funds to the Bakers View project, which is part of a larger effort to revive the Pennsylvania Avenue Corridor.

Additionally, the project received \$400,000 in State Baltimore Regional Neighborhood Initiative Funds and \$250,000 in additional State funds. Also, Druid Heights CDC received funds from Project CORE for stabilization work along Druid Hill Avenue.

Upon completion, Bakers View will feature 58 affordable townhomes that will overlook a public square that sits on 2.7 acres of high-quality green space.

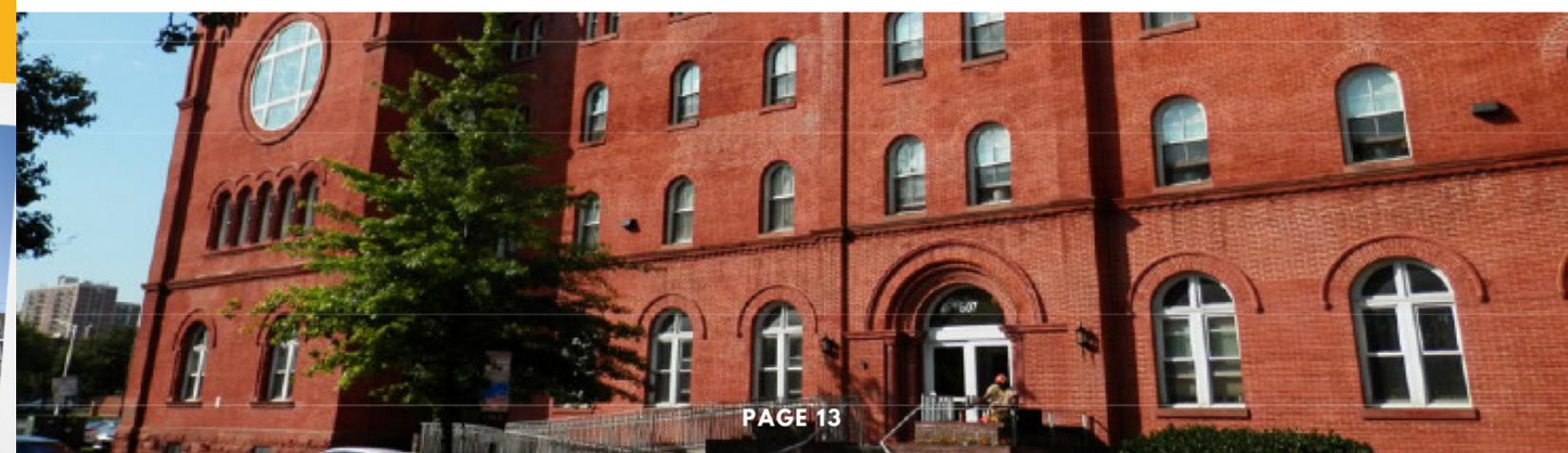

Charles R. Uncles Senior Plaza

Charles R. Uncles Senior Plaza is a 47 unit senior housing building renovated in 2000 at 607 Pennsylvania Avenue. The \$5.6 million project was financed with tax credits and grants from the State of Maryland Dhcd, Baltimore City DHCD, and Enterprise Community Partners. The 1983 building was originally used as Saint Joseph's Roman Catholic seminary. After DHCDC, Inc. renovated the building in 2000 for use as senior apartments, it names the property after the first African American Roman Catholic priest, Charles R. Uncles. The renovation preserved and accentuated remnants of the building's history, including the seminary's original chapel, which was converted to a community multipurpose room. The room is enclosed by an ornate arched ceiling and received light through an elegant circular window on the northeast end.





Housing Counseling

HOME BUYER COUNSELING

Clients receive counseling on identifying housing need, assessing affordability to purchase, credit counseling, household budgeting, reviewing mortgage products, reverse equity conversion programs, identifying for-sale and rental public and private properties, how to purchase HUD, VA and FHA homes, selecting real estate agents, predatory lending-“if it sounds too good to be true, It Is”, obtaining mortgage insurance, home inspections, property appraisals, how to inspect homes, understanding real estate terminology, negotiating sales contracts, fair housing laws, applying for mortgage financing, understanding settlement process, making timely mortgage payments, obtaining rehabilitation loans, refinancing, managing utility cost, property warranties, home maintenance, preserving assets before and after closing, consumer protection laws, periodic review of monthly household budgets, payment of real estate taxes, resale of properties, delinquency and default and loss mitigation strategies.

FINANCIAL CAPABILITY

Clients learn the importance having a solid financial foundation. They are counseled on all aspects of money management by assisting clients with budgeting and creating a savings plan. Counselors educate the client and assist in identifying barriers to success. There is a focus on understanding your credit score, how it impacts your financial health and most importantly, how you can improve your credit behaviors.

FORECLOSURE PREVENTION

Counselors assist clients by seeking resolution of mortgage default and delinquency problems. Clients receive counseling on alternatives to foreclosure such as forbearance relief, pre-foreclosure sale, deed-in-lieu of foreclosure, and refinancing. The Housing Counselor will verify the clients problem, identify the causes of default and delinquency, contact loss mitigation department to discuss alternative strategies, negotiate with lenders and creditors to prevent foreclosure, assess financial stability, establish household budget and credit management plan, establish a repayment plan and if necessary assist client with identifying alternative housing.

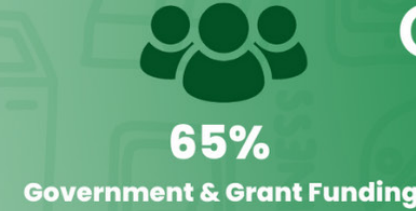
