Letter From The Founder



Mrs. Jacquelyn D. Cornish DHCDC

Almost 50 years ago, the historic Druid Heights community decided enough is enough. We determined that we needed to shake off the dust of disinvestment, roll up our sleeves and knock down the walls created by the devastation of the civil riots, as well as the loss of aged long-time homeowners, high levels of absentee landlords, poor municipal services, crumbling infrastructures, and financial disinvestment that ultimately led to the loss of critically needed services including access to fresh food.

Spearheaded by the rise in crime, drug use and the lack of municipal services, the community began to hold planning and strategy meetings and over time we formed productive partnerships with local, state, and federal government agencies, political representatives, philanthropic organizations, and some of the remaining community-based businesses and churches to remove the "Walls of Brewster Place." Walls that consistently stood against the community's goal of growth, self-empowerment, self-respect, and revitalization. Together, we began tearing those walls down.

Today, we continue to tear down the old walls and fight the increasing new walls of hit-and-run out-of-state investors whose only stake in the community is to buy low, renovate, sell high, and move on or sell to other investors who renovate and attempt to change zoning laws regarding the number of multi-family units per property that leads to an overcrowded community already overwhelmed with multi-family housing. Once upon a time, within the Druid Heights community, the ratio of owner-occupied homes and multi-family properties was approximately 70% owner-occupied - 30% tenancy. Today, less than 30% of homes are owner-occupied. Nevertheless, as a direct result of the hard and steady work of devoted residents, as well as the Druid Heights Community Development Corporation's staff, and the unwavering support of "in it to win it" partners, the needle is moving in favor of the community.

Our goal and vision have not changed. We are still unified. We still meet. Our plans and strategies have evolved. And we still humbly acknowledge that we can truly do little alone. But together, we continue to knock down the "Walls of Brewster Place" because we expect Druid Heights in the very near future to be seen as an intentional, economically balanced, destination community occupied by a diversity of involved residents, faith and worship establishments, and businesses that daily enjoy a safe, environmentally healthy place to raise families, work, provide goods and services and grow.







Maggie Quille Center Intergenerational Project

In our continued efforts to recognize individuals who are making outstanding contributions to the community, The Druid Heights Trumpet and Newsletter proudly salutes The Druid Heights Maggie Quille Community Center.

The Druid Heights Maggie Quille Community Center opened in 2003 and developed from Fire Engine House #25. Over the past 50 years, The Druid Heights Community Development Center (DHCDC) has served as an ambassador in community re-development throughout not only Druid Heights but also its surrounding neighborhoods. While the organization continues to pivot through the pandemic, the community need to continue to be great. DHCDC continues to serve low-moderate families, build affordable housing for first-time homebuyers, provide housing to senior citizens, provide transitional housing for women and children, and provide homebuyer counseling to residents.

The mission of DHCDC is to cause, encourage and promote community self-empowerment through the development of economic, educational, employment and affordable housing opportunities. DHCDC works to fulfill our mission through several departments which include real estate, housing counseling, community outreach and re-entry programs. The community center currently serves as a hub within the Druid Heights community. In addition, Druid Heights Community Development Corporation. The Druid Heights Maggie Quille Community Center provides youth services that include an after-school academic tutoring, homework assistance, and summer camp. These services are targeted towards our low-moderate income residents and families. The Druid Heights

Black Men United Youth Mentor Program



Druid Heights CDC is committed to providing meaningful and impactful programming for all youth participants. Connecting our team population and especially our boys to resources and outreach opportunities is vital to combating youth violence and delinquency in our community. In January 2023 Druid Heights partnered with Lonnie Walker, founder of J.O.Y Baltimore to bring the Black Men's United (BMU) Program to our teenage boys in the Druid Heights community. Black men's united is used to cultivate positive change and connect our boys to positive male role models and enhance the lives of young black men. The program participants met twice a week at the Community Center to discuss issues facing our boys today. This includes but is not limited to financial stability, building positive relationships, how to change negative behavior and the importance of black men's mental health. The program gave the boys an opportunity to experience different settings and events that they may not have experienced if not for BMU. The program concluded with a graduation where each individual participant's families had the opportunity to learn more about the BMU initiative. This outreach fed over 150 people a traditional Thanksgiving meal. Over twenty-five volunteers showed up to assist with the event. The purpose of this event was to show marginalized people within the community that they matter and are a central part of the work that Druid Heights CDC does daily.

Our Impact

On average, our program serves 50 returning citizens annually. As re-entry is a lifelong process, our program maintains ongoing connections with participants at various stages of their transition. One of the key highlights of our program is Men's Rap, a support group that offers participants the opportunity to talk with each other. Open to men and women, the group invites everyone from recovering addicts to ex-offenders who have changed their lives and working toward being productive members of society to offer support, encouragement, and motivation to live healthy lifestyles. Bakers View Ribbon Cutting

On the morning of October 25, 2023, at the corner of Baker & Division Street, the community witnessed the successful completion of four (4) units for Bakers View TownHomes! During the ribbon-cutting celebration, speakers included Mayor Brandon Scott, Council President Nick Mosby, Senator Antonio Hayes, Comptroller Henry, Councilman James Torrence, Howard Tutman (DHCD), and Mrs. Jacquelyn Cornish (Founder). The guest speakers spoke about the importance of the Bakers View project in the West Baltimore Community. Phase II includes the new construction of eight (8) units in the 2300 block of Division Street (2309-2323 Division Street). We would like to extend a special thank you to P&J Contracting, C.L. Myles Contracting, Arch Plan, KCW Engineering, Baltimore City Department of Housing and Community Development, Maryland Department of Housing and Community Development, Neighborhood Impact Investment Fund (NIIF) and Baltimore City Department of Planning.



Bakers View Ribbon Cutting

The City has eliminated more than 40 blighted properties for Phases I and II of the Bakers View

project. DHCD has committed over 1 million in bond funds to the Bakers View project, which is part of a larger effort to revive the Pennsylvania Avenue Corridor. In addition to securing the construction financing from Neighborhood Impact Investment Fund (NIIF), the project has received funding from State Baltimore Regional Neighborhood Initiative Funds (Maryland Department of Housing and Community Development), Enterprise Foundation, Bank of America and West North Avenue Development Authority. Upon completion, Bakers View will feature 58 affordable townhomes that will overlook a public square that sits on 2.7 acres of high-quality green space.

Druid House Transitional Housing

In 2000, DHCDC implemented the Druid House Transitional Housing Program which consists of 24 residential rental units. This project was financed using tax credits, grants and loans from the State of Maryland Department of Housing and Community Development, Baltimore City Department of Housing and Community Development, and Enterprise Community Partners. Druid House entails 14 units in the apartment complex located at 1711 McCulloh Street, which is a renovated apartment building with a community room and outdoor courtyard space for residents' use. Druid House also includes ten additional units which are located in duplexes along McCulloh Street. The Druid House Transitional Housing Program is one of the few programs that exist in Baltimore City that provides normal living apartments as shelter for women and children. The number of homeless women is steadily increasing with limited resources to assist this particular population. Druid House program goals and purposes is to provide homeless women and their 10 families with a safe environment and needed resources in order to promote independence and self-sufficiency.



Real Estate Development



Charles R. Uncles Senior Plaza

Charles R. Uncles Senior Plaza is a 47 unit senior housing building renovated in 2000 at 607 Pennsylvania Avenue. The \$5.6 million project was financed with tax credits and grants from the State of Maryland DhcD, Baltimore City DHCD, and Enterprise Community Partners. The 1983 building was orginal-ly used as Saint Joseph's Roman Catholic seminary. After DHCDC, Inc. renovated the building in 2000 for use as senior apartments, it names the property after the first African American Roman Catholic priest, Charles R. Uncles. The renovation preserved and accentuated remnants of the building's history, including the seminary's original chapel, which was converted to a community multipurpose room. The room is enclosed by an orna-mented arched ceiling and received light through an elegant circular window on the northeast end.
